# MINUTES CITY OF NEGAUNEE REGULAR MEETING APRIL 11, 2024

A Regular meeting of the Negaunee City Council was held on Thursday April 11, 2024 at the Negaunee Senior Center.

## APPROVAL OF AGENDA

A motion was made by Council Member Ilmonen, supported by Council Member Howard, and unanimously carried to approve the agenda as presented.

## **PUBLIC COMMENT**

Jacob Meyer addressed the Council regarding support for the compressor at the Ice Arena.

Eric Beckman addressed the Council regarding support for the compressor at the Ice Arena.

## BALLOT LANGUAGE – REZONING OF OLD TOWNE 5 ACRES

A motion was made by Council Member Smith and supported by Council Member Flohe to approve the ballot language as follows:

"The Negaunee City Council voted to amend the City of Negaunee's Codified Zoning Ordinance (Ord. No.: 156.031) to rezone an approximate five (5) acre parcel of City owned property, which is part of Old Town, from a Public Area (PA) Zoning District to a Residential (R2) Zoning District. Should the amendment to the Zoning Ordinance be repealed, reverting the subject parcel back to a Public Area (PA) Zoning District."

# ORDINANCE AMENDMENTS – 1ST READING – ADU'S IN RESIDENTIAL ZONES

A motion was made by Council Member Becker and supported by Council Member Flohe to approve the 1<sup>st</sup> reading of the amendments to ordinances #156.046, #156.047, #156.201 and set a public hearing and 2<sup>nd</sup> reading for the May 9<sup>th</sup> regular meeting.

Council Member Becker commented that this topic went through the planning commission and does align with the ordinances.

## MAIN STREET PAVING BIDS

A motion was made by Council Member Smith and supported by Council Member Becker to approve the low bid of \$109,877 to Bacco Construction Company for the paving of Main Street with an additional contingency of \$10,123.

Council Member Howard stated that this street has been done in the past and that there are worse streets in town that need to be done.

## LACOMBE FIELD FENCE BIDS

Two bids were received:

Century Fence: \$7290 Marquette Fence: \$14,500

\$23,425 is currently budgeted for this project.

A motion was made by Council Member Smith and supported by Council Member Ilmonen to approve the low bid of \$7,290 from Century Fence for the fencing at Lacombe Field.

## CITY HALL BOILER BIDS

The City Hall boiler needs repairs to continue operating. This is unbudgeted. Two bids were received:

United Contractors \$29,340 J Goods \$34,500

A motion was made by Council Member Ilmonen and supported by Council Member Smith to award the low bid of \$29,340 to United Contractors with monies being paid from the drawdown of the fund balance in the City Improvement Fund.

## LACOMBE FIELD DUGOUT BIDS

Four bids were received for this project.

A&F \$88,195 Closner \$88,270 Northern Awning \$70,150 Premeau \$58,675

\$23,425 is budgeted for this project.

A motion was made by Council Member Ilmonen and supported by Council Member Howard to reject all four bids as they are over budget.

# ICE ARENA COMPRESSOR

One of the compressors needs repairs at the ice arena. The city received a quote from Johnson Controls to perform the work in the amount of \$22,069.64 for compressor B2 and \$17,000 to purchase a spare compressor. This repair and purchase are unbudgeted.

A motion was made by Council Member Smith and supported by Council Member Flohe to approve Johnson Controls to replace compressor B2 in the amount of \$22,069.64 and \$17,000 for a spare compressor with the monies coming from a drawdown of the fund balance in the City Improvement Fund.

## **RESOLUTION – COMBINING VOTING PRECINCT POLLING LOCATIONS**

A motion was made by Council Member Smith, supported by Council Member Becker, and unanimously carried to approve the following resolution:

# Resolution Consolidating Election Precincts and Approving Election Precinct Polling Location

**WHEREAS,** MCL 168.661 allows for up to 4,999 registered voters to reside in a single precinct; and

**WHEREAS**, MCL 168.661 provides for the City Election Commission to establish precinct boundaries by resolution; and

**WHEREAS**, one election precinct (Precinct 1) in the City of Negaunee will reduce election day staffing needs, reduce election equipment needed, reduce the number of polling locations, and reduce other associated election costs;

**WHEREAS,** staff estimates this shift will result in a need for one Election Day polling location, rather than the two previously used; and

WHEREAS, a review of voter registration data, local voter habits and past practice regarding polling locations, resulted in a determination that the City would be able to provide the most accessible and equitable experience to City voters by establishing the one polling location at the Negaunee Middle School gymnasium (Precinct 1); and

**WHEREAS,** MCL 168.662(1) states, "The legislative body in each city and township shall designate and prescribe the place or places of holding an election for a city, village, or township election";

**NOW THEREFORE BE IT RESOLVED,** by the City Council for the City of Negaunee that the following consolidation and polling location be adopted for all elections in the City of Negaunee, until further modified:

• Precinct 1: Negaunee Middle School (new gymnasium), 102 W Case Street
