APPROVAL OF AGENDA

A motion was made by Council Member Visser, supported by Council Member Smith and unanimously carried to approve the agenda as presented.

RESIDENTIAL GARBAGE RATES

A motion was made by Council Member Wallner, supported by Council Member Saari and unanimously carried to amend the 2016 fee schedule to\$13.85 for the Solid Waste Disposal Residential per unit monthly amount starting with the next billing.

LAWN MOWER PURCHASE FOR THE PARKS AND REC AND CEMETERY

A motion was made by Council Member Gladwell, supported by Council Member Visser and unanimously carried that due to unusual circumstances it is authorized to purchase two gravely riding mowers from OK Rental Sales and Service of Ishpeming in the amount of \$18,771 using Parks budgeted monies and from the restricted Cemetery Fund.

MILLAGE DISCUSSION

City Manager Thornton stated that the current millages the City has, parks and recreation and the equipment fund would be expiring in 2017. He commented on possibly having a road millage, extending the equipment millage and the parks and recreation millage. After discussion it was decided to have the City Manager bring back options for the Council to review at the next meeting as the language for the ballot would need to be in by the end of April.
