A Regular Meeting of the Negaunee City Council was held on Thursday July 9, 2020 at 7:00 p.m. in the Negaunee Ice Arena.

APPROVAL OF AGENDA

Council Member Gladwell asked that #7.1 be added as Term Limits Discussion.

A motion was made by Council Member Maino, supported by Council Member Karki and unanimously carried to approve the agenda as amended.

PUBLIC COMMENT

No one from the Public wished to comment.

ORDINANCE AMENDMENT #1270 HOME OCCUPATIONS 2ND READING

Mayor Kangas opened the public hearing. No one from the public wished to comment. The public hearing was closed.

A motion was made by Council Member Wallner, supported by Council Member Maino and unanimously carried to approve the 2nd reading and adopt Ordinance Amendment #1270 Home Occupations.

ORDINANCE AMENDMENT #1286.07 FENCES, WALLS HEDGES 2ND READING

Mayor Kangas opened the public hearing. No one from the public wished to comment. The public hearing was closed.

A motion was made by Council Member Maino, supported by Council Member LaLonde and unanimously carried to approve the 2nd reading and adopt Ordinance Amendment #1286.07 Fences, Walls Hedges.

TIF INTERLOCAL AGREEMENT WITH MARQUETTE COUNTY

Mayor Kangas opened the public hearing. No one from the public wished to comment. The public hearing was closed.

A motion was made by Council Member Gladwell, supported by Council Member LaLonde and unanimously carried to approve the TIF Interlocal Agreement with Marquette County.

TERM LIMIT LANGUAGE DISCUSSION

A motion was made by Council Member Wallner, supported by Council Member Maino and unanimously carried to suspend the rules for discussion.

Council Member Gladwell stated that after the last council meeting, he took the discussion to mean that the council's consensus was for him to be able to run in the next election. Council Member Wallner stated that since the last meeting he has had discussion with the Clerk and it is in the realm of her job to make the call on whether someone is eligible to run or not. Council Member Maino questioned who has the right to make the call and if he made the motion would it stand. City Attorney Pickens stated that after discussions with the Clerk and County Clerk the Clerk has the authority to make the call and that per Charter the Council does not have the authority to force the Clerks decision. Mayor Kangas stated that it would be in Council Member Gladwell's court at this point whether to sue the City or not.

A motion was made by Council Member Wallner, supported by Council Member Maino and unanimously carried to reinstate the rules at this time.

A motion was made by Council Member Maino, supported by Council Member LaLonde and unanimously carried to purchase an ImageCast Precinct Tabulator and Ballot Box in the amount of \$5,295 with 50% of the cost being paid by the State of Michigan and \$2,000 budget adjustment paid from the General Fund Contingencies 101-925-969 to the Election Office Equipment Fund #101-192-980.

SET SPECIAL MEETING

A motion was made by Council Member Wallner, supported by Council Member Flohe and unanimously carried to set a special meeting for July 23rd at 6 p.m. in the Negaunee Ice Arena for the 2019 Audit.

CONSENT AGENDA

A motion was made by Council Member Wallner, supported by Mayor Kangas and unanimously carried to approve the Consent Agenda as follows: June 11, 2020 Regular Minutes, Claims and Accounts in the amount of \$875,086.84 (#80605-80719), Revenue/Expenditure Trial Balance Reports.

No one from the public wished to comment.

COUNCIL MEMBERS

Council Member LaLonde commented on the work being done around town, she is glad it is summer and happy for the in-person meeting. She stated that the 911 board had hired a new dispatcher.

Council Member Wallner commented on the MarqTran Board and routes and that ridership is down.

Council Member Karki commented that things are getting back to normal, the Senior Center parking lot looks good and work on Teal Lake Ave.

Council Member Flohe stated it was good to see everyone and the projects in town.
