LAND EXCHANGE AGREEMENT WITH NEGAUNEE SCHOOL DISTRICT

A motion was made by Council Member Stagliano and supported by Council Member Ilmonen and unanimously carried to approve the land exchange agreement between the city and the Negaunee School District, allowing the City Manager and City Attorney to execute such agreement and the make any necessary procedural changes, substantive, to facilitate the execution of the agreement and allow the City Manager to negotiate as it pertains to the paving of the road.

ALLEY BIDS

A motion was made by Council Member Flohe and supported by Council Member Kangas to accept the low bid from Bacco Construction in the amount of \$462,045.90 and an additional contingency for unforeseen issues in the amount of \$82,954.10 for a total project of \$545,000 contingent on bond funding with monies coming from the alley bond \$233,000, Electric Fund \$208,000, and the WW Fund \$104,000.
