Librarian's Report

Jessica's one-year anniversary as director was June 11.

The month of June has seen an upswing in attendance numbers, both in overall library visits and storytime attendance, especially since school ended for the summer. Seventeen children and nine adults attended the storytime session on June 9, and three babies and two adults participated in the Reading Rugrats session on June 15. Overall attendance was up from the first week of June to the second by roughly 20%. With the start of the summer reading programs, Jessica is optimistic that this trend will continue.

There has been an outpouring of community support for the inaugural adult summer reading program. Most businesses that Jessica approached for donations readily gave gift cards or similar prizes. With the exception of Snowbound Books in Marquette, all businesses supporting the adult summer reading program are in Negaunee. This is a great way to connect the library and community at large, advertise the participating businesses, and garner interest in the library and reading.

There will be a special program for children of all ages on Thursday, June 25. It will be about service dogs and therapy dogs, what they do, and how they differ from one another. Superiorland Pet Partners is sending some of its certified therapy dogs and their handlers, and Joe Holman (a Friend of the Library member and Jessica's father) will also be presenting with his service dog, Anthem.
