The blood drive is open to the public. Those interested in donating can call to make an appointment, or drop by between 10 a.m. and 1 p.m.

Donors must wait eight weeks between donations, be at least 17 years old, be free of flu, colds or sore throats and weigh at least 110 pounds. Donors should bring a picture ID with them when they come.

The U.P. Regional Blood Center is the sole provider of blood products to 13 hospitals across the U.P. All blood donations stay in the Upper Peninsula, and a single donation could save up to three lives.

### Beginners tai chi workshop offered

The Negaunee Senior Citizens ■ Center will host a workshop on May 7 for those interested in starting Tai Chi for Arthritis classes.

The workshop is geared toward older adults, and uses slow, controlled movements to strengthen and stretch all muscles of the body. Research shows increased balance, strength and flexibility as a result of regular tai chi practice.

The Tai Chi for Arthritis modality was founded by Dr. Paul Lam, who is a medical doctor diagnosed with arthritis himself. He used his tai chi training to help his own symptoms, and the CDC and arthritis foundations around the world have backed his work and methods.

The workshop will be two hours, with half being movement and half being instructional. Learning the benefits and methods of healing that tai chi uses is the basis; participants will get to see the form, and start doing some of the warm-up exercises to see if the class is for them.

Those completing the workshop will be polled to find out if a new beginners class will be started at the center in June.

**Senior housing survey available** help with a variety of things, includat center for older adults

The Negaunee Senior Center is working to advocate for appropriate senior housing options in our community, and we need your help.

If you would like to take the simple two-page survey, please stop by the center or call us and we'll mail you a copy. The survey is open to anyone 50 and older who may want to live in Negaunee now or in the future, and is considering a housing change.

To help developers understand what our aging residents are looking for in housing, the survey asks about renting versus owning, maintenance options, housing configuration, amenities, location and more.

The Negaunee Senior Center offers the following services:

 Case Coordination—Meet with our social worker, who can ing Meals on Wheels and other food assistance. Please call in advance to schedule a time to meet.

- Financial Management—Help understanding insurance and other bills, balancing checkbooks, etc. We have a certified counselor on staff to help with Medicare questions and enrollment.
- Homemaker Aide—General light household cleaning, laundry, light meal preparation, etc.
- Respite Care—Seniors or their live-in caregivers may qualify to have an in-home worker come to the home while the caregiver runs errands.
- Grocery Shopping Homebound clients may be eligible to have someone shop for them.

Income is not a factor in whether or not you qualify for in-home services. Physical and health factors are considered, as well as available assistance in the home.


Additional options include the Arnhem Airborne Museum, the Storm Surge Barrier and Flood Museum in Middelburg and the Kröller Müller Museum.




